## 3. Graphic Design Contract Components.

- 1. Textual Content. Textual content will be supplied already composed and typed by Michael Cheikin MD. Michael Cheikin MD may also elect to hire Greg Condon Design for copy writing services.
- 2. Photographs and Videos. Photographs and Videos will be supplied by Michael Cheikin MD in digital format.
- 3. Upload. Development of Graphics and other elements will take place on Greg Condon Design's development server. Greg Condon Design will upload the completed graphic designs and elements to Michael Cheikin MD's hosting web server for proof viewing. Corrections can be made at this time and reported to Michael Cheikin MD's hosting server.
- 4. Incidental expenses. Incidental expenses not in the price included expenses such as premium stock photography, themes, plugins, etc. While typically free or inexpensive, we

haven't yet determined what we need so I can't incorporate these items into the overall price.

Greg Condon Design reserves the right to display completed graphic design as part of a graphic design portfolio.

# 7. Payment of Fees.

In order for Greg Condon Design to remain in business, payments must be made in a timely manner. Payments are due by the dates outlined above. Outstanding balances that are 30 days past due will be assessed a late fee of 1.5% per each month of delinquency. Greg Condon Design reserves the right to hold graphics until final payment is made.
